**A Signature Guarantee** is designed to protect you and GMAC Demand Notes against improper transactions or requests by unauthorized persons. It can be obtained from a bank or financial institution. A Signature Guarantee is required for certain ownership changes, to add or change bank account information and to add or change redemption options. Each owner must have their signature guaranteed. Do not obtain one stamp for all owners. A Notary stamp will not be accepted.

**Automatic Monthly Investment:** Allows you to transfer funds electronically each month (\$50 minimum transfer) from a designated bank account to your GMAC Demand Notes. You will be credited on the transfer date you selected. Funds will be available for redemption six business days after the date of credit. When adding or changing the designated banking instructions for this option, there must be a match of at least one name between the designated bank registration and the Demand Notes registration (note: there is a set-up period of 10 business days each time you change or add banking instructions before this option can be used).

**Wire Transfer:** Allows you to transfer funds electronically (\$1,000 minimum transfer) from your GMAC Demand Notes by calling 1-800-684-8823; or through online access at [www.demandnotes.com](http://www.demandnotes.com). Call by 2:00 p.m. EST. and your funds will be transferred that day. If you are adding or changing this option, each owner must provide a **Signature Guarantee Stamp** in section 6.

**Automatic ACH Redemption:** Allows you to redeem a portion of your Demand Notes on a monthly or quarterly basis. You can only use this option if you maintain a minimum balance of \$5,000 in your Demand Notes. Your funds will be sent electronically via ACH to the bank account you have selected. If you are adding or changing this option, each owner must provide a **Signature Guarantee Stamp** in section 6.

**Automatic Monthly Interest ACH Redemption:** Allows you to redeem the monthly interest earned on your Demand Notes. You can only use this option if you maintain a minimum balance of \$5,000 in your Demand Notes. If you are adding or changing this option, each owner must provide a **Signature Guarantee Stamp** in section 6.

**Payroll Deduction:** GMAC Demand Notes accepts payroll deduction as an investment option. All investors are responsible for starting or making changes to their payroll deductions. If your workplace is not included in the list below, please contact your HR or Payroll department for further assistance. Have your Demand Notes number ready and follow the automated prompts. Allow two pay periods for the change to be effective.
